Membership in the Berwick Golf Club. Upon acceptance of my application, I agree:

1. I agree to a one year contract with Berwick Golf Club with golf dues as follows: 20% down payment (plus handicap fee) with remaining dues being divided into 12 monthly payments starting November 2010. Current dues charges will be valid for 12 months from the time the membership application is accepted by the Berwick Golf Club. Additionally, I am responsible for a \$35 food chit fee (March – December).
2. Membership will automatically renew each year unless written notification is submitted to the Board of Directors prior to the end of the current contract, and thereafter prior to the end of the fiscal year of the current golf season. After the first year of membership dues will be billed on a monthly basis with fees as established by the Board of Directors and club By-Laws. I am responsible for all charges/debt I incur from using any club facilities.
3. I understand that because I am not being issued a share of stock at this introductory offer, I am not entitled to voting privileges, nor am I subject to additional fees and capital assessments for the period of the contract.
4. I understand monthly payments must be received by the club prior to the last business day of each month. All club privileges will be suspended until outstanding balance is paid in full.
5. If I default in payment of any obligation I may owe to the Berwick Golf Club, I/we agree to pay all costs of collection, including reasonable attorney fees. If married, we agree this membership is our joint obligation.
6. At the end of my 1 year term, I agree to pay a one time stock fee and the current dues for my classification as set by the Board of Directors unless I submit written notification of my resignation to the Board of Directors before the 1 year term expires. Note: The Berwick Golf Club is currently in the process of an Equity conversion. The stock fee may change or be deemed optional as part of a golfing membership to the Club.
