



BGC 2011-12 Memberships & Rates

GOLF MEMBERSHIPS:

SINGLE GOLF MEMBERSHIP (SGM) – Age 21 and above dues \$1,500.00 (\$125.00 per month) plus carts* and food minimum**, and \$50 one time stock purchase. Members children, under the age of 18 or a full time student under the age of 23 of the golfing member(s), shall be entitled to golfing privileges as established by the Board of Directors.

FAMILY GOLF MEMBERSHIP (FGM) - Full golf privileges for member and spouse/significant other dues \$2,040.00 (\$170.00 per month) plus carts* and food minimum**, and \$50 one time stock purchase. Members children, under the age of 18 or a full time student under the age of 23 of the golfing member(s), shall be entitled to golfing privileges as established by the Board of Directors.

NON RESIDENT GOLF (NRG) – Primary and secondary residence outside 50 miles; full golf privileges (1); Total Annual dues \$800 plus carts***. Individual NRG may play in all member tournaments.

CORPORATE GOLF (CRG) –Dues \$2,100, no food minimum. Limitations: Total of 40 rounds with cart; 10 play limit per person.

JUNIOR (JUN) - Non member dependent under age 21 or under age 23 if full time student in College, dues \$350 plus carts***; no food minimum. Limitations: Wed., Thurs., Sat., Sun., and holidays after 2:00 pm; no Club sponsored function, outing, tournament, or event.

SOCIAL MEMBERSHIPS:

SOCIAL SINGLE (SSM) - 21 yrs or older; clubhouse privileges only (1); \$35 Total Annual Dues; \$15/month food minimum billed monthly (Nov, Dec, Mar-Oct \$15/month; must be used in same month). Limitations: No golfing privileges.

SOCIAL MARRIED (SMM) - 21 yrs or older; clubhouse privileges only (2); \$50 Total Annual Dues; \$15/month food minimum billed monthly (Nov, Dec, Mar-Oct \$15/month; must be used in same month). Limitations: No golfing privileges.

CORPORATE SOCIAL (SCM) – Social Dining Privileges; \$250 Total Annual Dues plus \$15/month food minimum billed monthly (Nov, Dec, Mar-Oct \$15/month; must be used in same month). Limitations: No golfing privileges.

*Carts: Shareholder: Billed per usage at \$17.00 per 18 holes, \$9.00 per 9 holes
Optional Cart Packages: \$400 for 25 rounds; \$775 for 50 rounds; \$1500 for 100 rounds (if purchased, the shareholder can save 6.25% - 11.8% over normal cart fees). For existing members, the cart package must be purchased by 12/23/11; after that date they will not be eligible to purchase a package. The package will be billed in equal monthly payments but must be paid in full no later than March 31, 2012. For those who buy a package, additional packages can be purchased after the existing package is used in full. New member's (not previously a golfing member of the BGC during the last fiscal year) eligibility to purchase a cart package will expire after the first 30 days of their membership being accepted. Cart packages may be shared between a shareholder and the shareholder spouse/significant other, who are both BGC golfing members.

** Monthly Food Minimum (Chit) billed \$400 over 10 months (Nov, Dec, Mar – Oct, \$40/month). The food chit will be billed monthly and billed in advance; it must be used in the same month or lost.

***Carts: Non-shareholder: Billed per usage at \$19 per 18 holes, \$10 per 9 holes
